RAILROAD COMMISSION FINALIZES "UNCONVENTIONAL FRACTURE TREATED" FIELD RULES

This month, the Texas Railroad Commission unanimously approved changes to Statewide Rule §3.86 and conforming amendments to other state rules relating to unconventional fracture treated fields ("UFT fields"). For over a year, the agency has been working to update and streamline existing regulations that pertain to horizontal development and production in Texas.

Through the adopted amendments, the commission will establish a procedure for designating certain fields as "UFT fields," which are classified as fields in which horizontal drilling and hydraulic fracturing must be utilized by an operator to recover resources. As defined by the commission, UFT fields may be developed using either vertical or horizontal drilling techniques. The new UFT rules will promote horizontal development and production in the Lone Star State after synchronizing traditional regulatory approaches with issues unique to horizontal drilling. The rules will also accommodate procedural efficiencies and will dramatically reduce the administrative burden on RRC staff and operators alike. New approaches to allowables and acreage assignments will also encourage operators to continue development, maximize production, protect correlative rights and eliminate waste in all fields that receive the UFT designation.

PAST TIPRO CHAIRMAN DAVID F. MARTINEAU ANNOUNCES RETIREMENT

At the end of 2015, Mr. David F. Martineau, one of TIPRO's long-standing members and leaders, announced his retirement from Pitts Oil Company, LLC, after 44 years with the company and 56 years working for the oil and gas industry. David was the exploration manager for Pitts, where he was in charge of the evaluation and selection of new exploration programs.

David was also the third person from Pitts Oil to serve as a chairman of TIPRO, following in the footsteps of L. Frank Pitts and Shelby D. Pitts. In the 70-year history of TIPRO, not often have there been three individuals from the same company chosen to lead our association!

David first joined TIPRO on June 1, 1979, and for more than 36 years, has been an active part of our organization. On behalf of TIPRO, he has testified before the U.S. House Subcommittee on Energy and Environment, Environmental Protection Agency (EPA), Texas Railroad Commission, Texas House and Senate Subcommittees, and even participated in a forum at the National Press Club in Washington D.C.

He also testified numerous times before the Dallas City Council and Denton City Council when anti-oil and gas environmentalists caused ordinances to be passed that would prohibit hydraulic fracturing within their city limits. However, with the hard work of individuals like David, the industry has fought back, and as we know, ultimately the state overruled these types of ordinances through the passage of House Bill 40 in 2015.

As TIPRO chairman, David also initiated new opportunities to promote our sector, including leading TIPRO to New York in 2013 to ring the opening bell at NASDAQ. Joined by member executives, this trip was a unique platform for TIPRO to highlight the advocacy work of our association and showcase the positive economic impact of the Texas oil and gas industry.

Over the years, we also have watched David alongside his wife of 54 years raise two children and three grandchildren, who have come to TIPRO events and helped fill the TIPRO photo albums with their families.

In general, David has enjoyed educating the public and local, state and federal leaders. He has received numerous awards and accolades for his work, including recognition on the "Who's Who in Energy" list from the Dallas Business Journal, Public Service Awards from the Dallas Geological Society and American Association of Petroleum Geologists, the Energy Ambassador's Award from the Texas Energy Council, and being named as an "Industry Legend" from the Oil and Gas Investor Magazine.

David's career has led him through many roles outside of the geoscience field and onto boards where his contributions to professional societies, education systems and associations have been immeasurable.

PRESIDENT'S MESSAGE

TIPRO Members-

This week, we've watched oil prices continue to spiral downward, even dipping below \$27 a barrel. Weak commodity prices are the result of ongoing concerns about an oversupplied market. As reports continue to confirm the rising global inventory of oil, analysts are warning of the long-term impact that sustained low oil prices could pose to the economy. The "lower for longer" sentiment expressed frequently during 2015 has shifted to "lower for even longer" for many investors, analysts and operators.

Adding insult to injury, the Obama Administration's so-called diplomatic victory with Iran, and subsequent lifting of sanctions, is the latest blow to domestic producers and our economy. Iran is expected to increase production by 1 million barrels of oil per day within the next 8-12 months, putting further pressure on global supply.

Iran has also assembled one of the largest fleets of supertankers in the world in anticipation of this day. Iranian production is approximately 2.9 million barrels a day, much of which has been sold to customers in Asia with prior sanctions cutting off Iran from exporting to other countries. Showing another sign of their aggressive intentions, the National Iranian Oil Co. recently cut its official selling price for Northwest Europe, a market that was previously challenging to access due to sanctions. Regardless of occurring at one of the worst times with sub-\$30 oil prices, Iran is eager to unleash a tidal wave of crude.

Despite the continued downturn in commodity prices and mounting challenges affecting global supply, U.S. independents have been remarkably resilient. Fortunately the demand for oil is set to grow to 96.5 million barrels per day (bpd), an increase of 1.2 million bpd from 2015. While a slowdown in China's economy is an area of concern, demand for oil continues to grow in that country, albeit at a slightly slower pace. Growing global demand, greater efficiencies in exploration and production methods, ongoing innovation and the significant policy victory of lifting the ban on U.S. oil exports will position us well in the years to come. This will indeed be a challenging year, but when prices do eventually rebound, domestic producers will be stronger, more competitive and efficient, which will only enhance the leadership of the U.S. oil and natural industry in the global marketplace.

Unfortunately, until the rebound occurs, the low price of oil won't deter some lawmakers from advancing onerous policies targeting our industry, as well as the relentless efforts from anti-oil and gas organizations, like Earthworks, the Sierra Club and the Environmental Defense Fund. TIPRO continues to monitor all issues that impact our membership, including factors affecting global supply and demand, as well as all state and federal energy policies that could impact the E&P sector. Not only do we anticipate another difficult year for commodity prices, but we will also likely see a significant increase in anti-oil and gas regulations and related proposals during the last year of the Obama Administration.

TIPRO remains committed to protecting and strengthening our industry through ongoing advocacy efforts and promotion of sound public policy. Our impact and many substantive contributions over the past 70 years would not have been possible without the ongoing support of our members. Thank you for your continued involvement and many contributions.

EPA SCIENCE ADVISORY BOARD TO HOST TELECONFERENCE ON HYDRAULIC FRACTURING REPORT

The U.S. Environmental Protection Agency's Science Advisory Board (SAB) will hold a series of public teleconferences to review and discuss the EPA's draft report, "Assessment of the Potential Impacts of Hydraulic Fracturing for Oil and Gas on Drinking Water Resources." The EPA will use feedback from the SAB, along with the comments from members of the public, to evaluate how to augment and revise its draft assessment. The public teleconferences will be held on the following dates: February 1, February 2, March 7, and March 10. Recently, environmental groups have pressured the EPA to reverse its findings on the relationship between hydraulic fracturing and drinking water. TIPRO has joined with several other regional and national oil and gas industry associations in encouraging the federal agency to uphold its previous scientific assessment that "there is no evidence of widespread, systematic impacts on drinking water resources due to hydraulic fracturing activities."

NEW TEXNET SEISMIC MONITORS TO BE INSTALLED THIS SPRING

New seismic monitors will be installed across the state over the coming months to assist research efforts to identify and understand the cause of seismic events in Texas. Last year, the Texas Legislature approved \$4.5 million in funding for a comprehensive earthquake study; \$2.47 million of which is dedicated to purchasing necessary equipment to establish a “TexNet” system, and the remaining \$2 million to be used for studying data results.

With the start of 2016, a vendor for providing the equipment has been selected, and a new project director, Alex Savvaidis, has been hired to lead the initiative. Savvaidis will begin his work in February.

WILL FALLING OIL PRICES AFFECT ROAD INFRASTRUCTURE DEVELOPMENT IN TEXAS?

In wake of plummeting oil prices, state leaders are now reviewing any potential impacts to available funds dedicated to Texas road infrastructure development. On Wednesday, January 20, members of the Texas House Select Committee on Transportation Planning convened at the state capitol in Austin to listen to testimony from Texas Comptroller of Public Accounts Glenn Hegar regarding Proposition 1 and Proposition 7 funding for the upcoming year leading into the next biennium. As approved by voters, the two constitutional amendments divert portions of Texas’ oil and gas tax revenue from the Rainy Day Fund into the State Highway Fund, in support of road construction and maintenance across Texas.

Relaying an optimistic tone, Comptroller Hegar reassured lawmakers that the current slowdown will not mimic the devastating crash of the 1980s. Because Texas has diversified its economy, the state is now better positioned to respond to the lower severance tax receipts without drastic changes to its budget. Nevertheless, transfers into the State Highway Fund are anticipated to decrease due to the reduction in oil and gas severance tax revenue, but long-term economic trends still look positive.

According to the comptroller, based on Fiscal Year 2015 collections, approximately \$1.1 billion was transferred to the State Highway Fund for Fiscal Year 2016. The comptroller projects the Fiscal Year 2017 transfer in severance tax funds will total \$594 million. Based on current economic data, Texas is still on track to transfer \$375 million from motor vehicle sales and rental taxes in Fiscal Year 2018, assuming a 50/50 split between the Highway Fund and Rainy Day fund will continue as provided in existing statute, Hegar reported to the legislative committee.

During Wednesday’s committee hearing, legislators also received an update from the Texas Department of Transportation (TxDOT) on selection criteria, rules and policies for road funding projects, as the agency works to address transportation infrastructure needs in regions across Texas.



ENVIRONMENTALISTS ASK THE EPA TO STRIP TEXAS OF REGULATORY CONTROLS

In a petition filed January 11, 2016, the Environmental Defense Fund (EDF) and Caddo Lake Institute (CLI) requested the U.S. Environmental Protection Agency (EPA) review and withdraw its delegations of permitting authority to the Texas Commission on Environmental Quality (TCEQ), the chief environmental regulatory agency operating in the state of Texas. The two environmental groups are demanding that the federal government revoke the state’s permitting authority as provided under the Clean Air Act’s New Source Review program and the Clean Water Act’s National Pollution Discharge Elimination program.

Texas Governor Greg Abbott and the state legislature are unjustly criticized in the petition, specifically for amending Texas law in 2015 in a capacity that supposedly prevents the TCEQ from adequately implementing and enforcing its delegated programs. “They passed and signed laws, respectively, that resulted in Texas’s clean air and clean water programs no longer meeting minimum legal safeguards, which puts the health of Texas families at risk,” alleges Jim Marston, EDF vice president and regional director. “The legislature also has repeatedly underfunded the state environmental agency to the point that the TCEQ cannot adequately do its job. Sadly, because our current officeholders will not protect Texans from dangerous pollution, we have no choice but to ask EPA to exercise its fundamental duty under the Clean Air and Clean Water Acts and to retake responsibility to administer these vital national health programs.”

Despite claims propagated by the EDF and CLI, Texas maintains a solid record of successfully regulating industrial activities to protect public health and natural resources. The TCEQ verifies that the state has - and continues to - meet all federal requirements. The agency expects the EPA to “reject this frivolous petition.” The EPA commented that at this time “it was not aware of significant deficiencies in TCEQ-delegated environmental programs.”

SHALE DEVELOPMENT SAVES AMERICANS MONEY AT THE GAS PUMP

With a skyrocketing inventory of U.S. oil supplies - thanks to increasing shale development across the country - Americans are enjoying substantial savings when they stop by the gas station to fuel their cars. U.S. gasoline prices are markedly down, now hitting seven-year lows, reports the U.S. Energy Information Administration (EIA). For the first time since March 2009, average retail gasoline prices have dipped below the \$2.00/gallon benchmark.

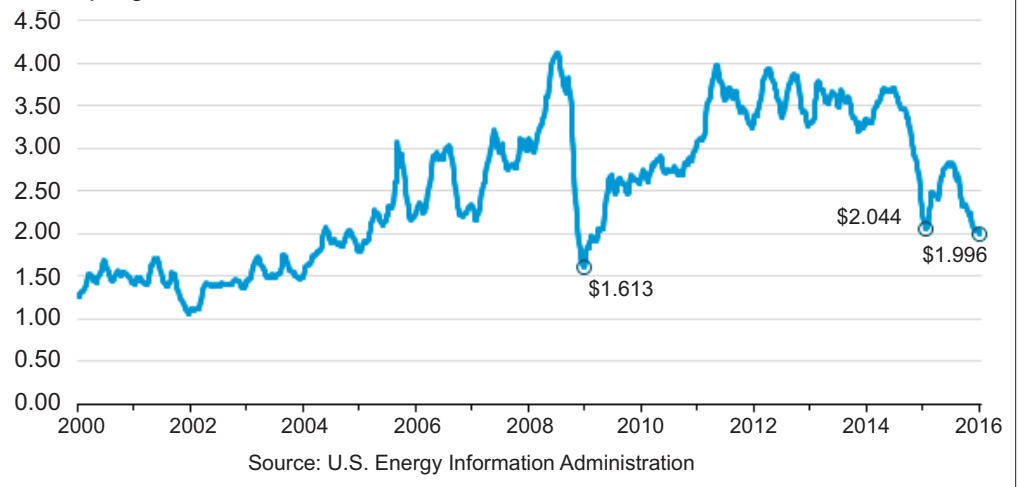
“The price of U.S. retail regular gasoline is forecast to average \$2.03/gallon in 2016 and \$2.21/gallon in 2017, compared with \$2.43/gallon in 2015,” projects the federal data agency. “In December, average retail regular gasoline prices were \$2.04/gallon, a

decrease of 12 cents/gallon from November, and 51 cents/gallon lower than in December 2014. The EIA expects monthly retail prices of U.S. regular gasoline to reach a seven-year low of \$1.90/gal in February 2016, before rising during the spring.”

Those living in Texas are especially benefitting from the low gasoline prices. “Texas ranks among the top ten states with the least expensive statewide gas price averages in the country right now,” said AAA Texas/New Mexico Representative Doug Shupe. Meanwhile, gasoline prices on the West Coast have tended to be higher than elsewhere in the country because of the region's relative isolation from other gasoline markets and higher state taxes, notes the EIA.

The EIA estimates that lower gasoline prices could save average U.S. households as much as \$280 in 2016.

HALLIBURTON OPENS NEW SAND PLANT IN THE EAGLE FORD



A new sand facility has opened south of San Antonio to serve operators in the Eagle Ford Shale. In early December, Halliburton proudly opened its Elmendorf South Texas Sand Plant with a ribbon-cutting ceremony. According to the company, the Elmendorf Plant is the largest Halliburton sand facility in the world and represents a \$35.7 million investment.

“This is good for our customers, and gives Halliburton a competitive, long-term advantage in this South Texas market,” commented Paul Sheppard, vice president of Halliburton’s Southeast Area.

The facility is located at the Alamo Junction Rail Park in the South Texas town of Elmendorf, and houses eight silos and a laboratory. It has the capability to offload 150 railcars and load 450-500 trucks daily.
