Introduction

TIPRO is pleased to release employment and establishment data for the U.S. oil and gas industry from the first quarter of 2017, the most current data available at the time of publishing this report. A full "State of Energy Report for 2017" will be compiled upon the release of updated U.S. census data and will include additional economic data tracked by TIPRO, including wages, payroll, and oil and natural gas production figures.

Key state and national findings:

- The U.S. oil and gas industry experienced a net loss of 21,521 jobs in the first quarter of 2017 compared to FY 2016. U.S. oil and gas jobs totaled 829,718 in the first quarter of the year.
- The U.S. oil and gas industry gained a combined 12,979 jobs in the Drilling Oil and Gas Wells and Support Activities for Oil and Gas Operations sectors in the first quarter of 2017.
- The U.S. oil and gas industry lost 1,348 oil and natural gas establishments in the first quarter of 2017, for a total of 40,337.
- Texas lost 12,007 oil and gas jobs in the first quarter, the largest decline in the country, for a total of 313,408 jobs.
- The Texas Oil and Gas Extraction Sector experienced the biggest drop in employment between 2016 and the first quarter of 2017, with a net loss of 17,870 jobs.
- Texas had a net positive gain in employment in five of the nine industry sectors in the first quarter of 2017 compared to FY 2016.
- Texas added 218 new oil and gas businesses in the state, the largest increase in the country. Total oil and gas related businesses in the state was equal to 12,500.

All data is derived from the U.S. Bureau of Labor Statistic's QCEW (Quarterly Census of Employment and Wages) Series. The data from this source provides the most comprehensive source of industry data at the state level and allows for a true state-by-state comparison using the same data source. This series collects data from the state unemployment reports and as a result supplies a census of employment and establishments information. Establishments are single economic units, usually a single location. Companies often have multiple establishments at multiple locations. The term "businesses" may be used to refer to an establishment to facilitate ease of use and understanding. 2017 data is for the first quarter of the year. As such, the 2017 data does not represent the complete year of 2017, and will tend to undercount sectors that are growing when compared with the full year of 2017.
