UNITED STATES TO HIT RECORD LEVELS OF FOSSIL FUEL PRODUCTION IN 2018 AND 2019

Analysts with the U.S. government anticipate that this year America will enjoy its highest level of fossil fuels production on record, with even greater output expected by 2019. In the latest *Short-Term Energy Outlook* (STEO), released by the U.S. Energy Information Administration (EIA), experts forecast total U.S. fossil fuels production -- including crude oil, dry natural gas, coal and hydrocarbon gas liquids -- to average almost 73 quadrillion British thermal units (Btu) in 2018. A year later, production will grow to as much as 75 quadrillion Btu in 2019. As the nation's top producing state, Texas will account for a substantial portion of the supply growth.

Looking more specifically at U.S. crude oil output, the EIA estimates that U.S. crude oil production will rise 10 percent from 2017 levels, averaging 10.3 million barrels per day (b/d) in 2018 to accomplish the highest annual average production in U.S. history. By late 2019, EIA forecasts oil output to increase to an average of nearly 11 million b/d. "Increased production from the Permian region in Texas and New Mexico accounts for most of the projected increase in the U.S. total," according to the agency. "EIA also expects a significant contribution to crude oil production growth from the Federal Gulf of Mexico, as seven new oil-producing projects are slated to come online by the end of 2019."

Meanwhile, U.S. dry natural gas production this year is expected to go up 9 percent from 2017 levels, averaging 80.4 billion cubic feet per day (Bcf/d) in 2018. If achieved, this would represent the highest year-over-year increase on record. By 2019, dry natural gas production in the U.S. will set another record, with production estimated to hit 83.0 Bcf/d. Growth is likely to be concentrated in Appalachia's Marcellus and Utica shale formations along with the Permian Basin in Texas and New Mexico, signals the EIA.

With regard to market conditions, the EIA suggests Brent crude oil prices will average \$60/b in 2018, and then hover around \$61/b in 2019. West Texas Intermediate (WTI) crude oil spot prices are forecast to average \$4/b less than Brent prices in both 2018 and 2019, reports the EIA. In the meantime, Henry Hub natural gas spot prices are likely to average \$2.88 per million British thermal units (MMBtu) in 2018 and \$2.92/MMBtu in 2019, compared with the 2017 average of \$2.99/MMBtu, the EIA indicates.

Much like the EIA, the International Energy Agency (IEA) also expects the United States to strengthen its oil and gas output during 2018, putting the country on pace to become the world's largest oil producer. "This year promises to be a record-setting one for the U.S.," the IEA said in January. "Relentless growth should see the U.S. hit historic highs above 10 million barrels a day (in production), overtaking Saudi Arabia and rivaling Russia during the course of 2018."



PARTISAN DIVIDE LEADS TO GOVERNMENT SHUTDOWN IN D.C.

Beginning on Saturday, January 20, 2018, the federal government shut down for several days after lawmakers failed to strike a deal and pass an appropriations bill before a key statutory deadline. Disagreements between the Republican and Democratic parties over contentious issues, such as immigration, funding of a border wall and other key government programs, extended the government shutdown through the weekend into the start of the work week.

By Monday afternoon, January 22, however, members of Congress reached an agreement to approve a short-term funding bill that would keep the government running through Thursday, February 8, allowing the government to re-open while officials continue to work to resolve differences on larger issues. President Donald Trump signed the legislation into law the same day it passed out of Congress.

Despite the shutdown, federal employees at the U.S. Environmental Protection Agency (EPA) were told to continue to report to work, as the agency had enough money to continue operations for a limited amount of time. Other branches of the government, including the U.S. Energy Information Administration (EIA), also continued operations, despite the temporary federal government shutdown.

SENATE NATURAL RESOURCES & ECONOMIC DEVELOPMENT COMMITTEE TO MEET FEBRUARY 1ST

During the committee's first hearing of the year, members will examine options to maintain the state's competitive edge, considering recommendations to remove or reduce administrative or regulatory barriers that hinder economic growth, including permitting or registration requirements and fees.

The committee will also look at the collection and use of hotel occupancy taxes, studying options to increase transparency in the imposition, rate, and use of such taxes.

The February 1st legislative hearing will begin at 9 a.m. at the Houston City Council Chamber, located on the second floor of City Hall at 901 Bagby Street, Houston, Texas, 77002.

On behalf of the association's membership, TIPRO will be in attendance of the committee's hearing in Houston.

RRC TO REVIEW IMPACT OF FEDERAL TAX REFORM ON TEXAS GAS UTILITY RATES

During the Texas Railroad Commission's January 23rd open meeting, Texas Railroad Commission Chairman Christi Craddick directed agency staff to complete a review assessing the impact of the *Tax Cuts and Jobs Act of 2017* on Texas gas utility rates to ensure companies pass on to customers the savings resulting from the corporate tax reduction.

"These tax cuts are significant, and as a regulator, our role is to make sure Texas utilities implement them in a way that benefits consumers first," Chairman Craddick said. "Considering President Trump's tax reform plan and the reduced corporate tax rate, we will look at the effect on gas rates to guarantee companies share their savings with their customers, allowing Texans to keep more of their paycheck as the Act intended."

RAILROAD COMMISSION CHAIRMAN URGES FEDERAL LEADERS TO REFORM NAFTA, NOT END IT

Christi Craddick, chairman of the Railroad Commission of Texas, is calling on federal officials to uphold the North American Free Trade Agreement, known as NAFTA, amid talk in Washington D.C. of ending the deal. In an editorial published in the *Houston Chronicle* earlier this month, Craddick outlined the value of NAFTA to Texas, citing in particular the importance of the agreement to the state's energy industry, as new trade opportunities emerge with neighboring nations like Mexico.

"Texans know when it comes to trade agreements like NAFTA, the answer is to mend it, not end it. President Trump must be urged to recognize the agreement's importance to our state, because the alternative would be detrimental to the Texas and American economy," Chairman Craddick emphasized.

"We need a North American energy strategy, in partnership with Mexico and Canada, that leverages our shared energy potential," Craddick advised. "We can achieve energy security as a continent, greatly reducing our reliance on hostile sources of energy, if we work across shared borders to advance shared economic and security interests. Doing this requires not withdrawing from NAFTA or harming long-standing trade relationships with our neighbors, but sitting down to hash out agreements about renewable standards and environmental commitments, focusing on joint infrastructure projects, and agreeing to 21st century rules and regulations that advance our collective prosperity."

GOVERNOR ABBOTT UNVEILS PROPOSAL TO LIMIT PROPERTY TAXES IN TEXAS

Texas Governor Greg Abbott has set forth new plans to limit annual growth of local governments' property tax revenue in hopes of reining in skyrocketing property taxes that have been adversely impacting residents of the Lone Star State. The governor pitched his ideas for property tax reform at a news conference held Tuesday, January 16th in Houston, joined by Lt. Governor Dan Patrick and several other state lawmakers. "With the skyrocketing rise in property taxes, more and more Texans face the risk of being forced out of the homes they have lived in for decades," said Governor Abbott. "Young families who are just starting out are having trouble affording their first home and businesses are unable to grow and hire more workers. Enough is enough. Under the plan I am announcing today, Texas will take action to limit property tax growth, secure private property rights and ensure that Texas remains the most exceptional state in the nation."

Under Governor Abbott's property tax plan:

- A 2.5 percent revenue growth cap would be placed on property tax revenue per year. Voter approval would be required if local governments wanted to raise the cap to more than growth in population and inflation.
- Locally elected officials who oversee taxing districts would have to vote to increase property appraisals, making the process more transparent and holding elected leaders accountable to the voter for increases in property taxes.
- Local governments would be forced to post their debt obligation online, and required to achieve a two-thirds supermajority vote to approve the issuance of new local debt. Debt would be prohibited from being used for non-specified purposes, and the use of certificates of obligation would be restricted.

The Texas legislature, set to convene next January for the 86th Legislative Session, would have to approve the governor's proposal before changes to property taxes would be allowed to take effect.

TEXAS ATTORNEY GENERAL APPLAUDS SUPREME COURT FOR TAKING UP TEXAS REDISTRICTING CASE

Later this spring, the U.S. Supreme Court will review the validity of Texas' congressional and House maps, the high court announced in mid-January. The decision by the Supreme Court to take up Texas' redistricting case follows a ruling that was issued last August from the U.S. District Court in San Antonio which invalidated two of Texas' 36 Congressional districts (27 and 35) as well as nine state House districts. Texas Attorney General Ken Paxton subsequently appealed the rulings to the high court, which blocked them from taking effect.

In light of the Supreme Court's announcement that the justices will consider the state's redistricting case, Paxton issued the following statement: "We are eager for the chance to present our case before the U.S. Supreme Court, which ordered the district court in San Antonio to draw lawful congressional and House maps in 2012 that the Legislature adopted in 2013 and used in the last three elections. The lower court's decisions to invalidate parts of the maps it drew and adopted are inexplicable and indefensible."

SUPREME COURT RULES CLEAN WATER RULE LITIGATION BELONGS TO DISTRICT COURTS

The U.S. Supreme Court ruled on Monday, January 22nd that the legal battle over the controversial ‘Waters of the United States’ (WOTUS) regulation belongs in federal district courts, rather than appellate courts. The rule, which was implemented under the Clean Water Act by the Obama Administration’s Environmental Protection Agency (EPA), has faced a series of challenges since being finalized in 2015, the most recent of which being debate over the appropriate venue to handle judicial review of the policy. After considering the case, this week the Supreme Court found that lawsuits relating to WOTUS should be considered at the district level.

“Generally, parties may file challenges to final EPA actions in federal district courts, ordinarily under the Administrative Procedure Act (APA). But the Clean Water Act enumerates seven categories of EPA actions for which review lies directly and exclusively in the federal courts of appeals. The Government contends that the WOTUS Rule fits within two of those enumerated categories: (1) EPA actions ‘in approving or promulgating any effluent limitation or other limitation under section 1311, 1312, 1316, or 1345,’ 33 U. S. C. §1369(b)(1)(E), and (2) EPA actions ‘in issuing or denying any permit under section 1342,’ §1369(b)(1)(F). We disagree. The WOTUS Rule falls outside the ambit of §1369(b)(1), and any challenges to the Rule therefore must be filed in federal district courts,” advised the Supreme Court justices in their decision.

IN NEW INTERVIEW, EPA’S SCOTT PRUITT LAYS OUT GOALS FOR SECOND YEAR ON THE JOB

U.S. Environmental Protection Agency’s chief leader Scott Pruitt hopes to amplify efforts geared towards remaking the agency in 2018, the EPA administrator revealed in a new interview with the *Wall Street Journal*. In mid-January, Pruitt said he wants to speed up the EPA’s permitting processes and transform a culture he finds to be too bureaucratic. He also outlined goals of repealing and rewriting federal rules on power-plant emissions.

Since taking office as EPA administrator last February, Pruitt has pursued a “Back-to-Basics” agenda at the agency, which strives to refocus the EPA back to its intended mission, rescind unnecessary government regulation and establish sensible rules that enhance economic growth while protecting the environment. Under Administrator Pruitt, over the past year the EPA has already issued 20 deregulatory actions to save the American people more than \$300 million in regulatory costs.

FEDERAL OFFICIAL INDICATES FLORIDA STILL BEING CONSIDERED FOR OFFSHORE DRILLING

Despite a decision from Interior Secretary Ryan Zinke to leave the state of Florida out of proposed plans for offshore drilling, the acting director of the Bureau of Ocean Energy Management (BOEM) advised a congressional subcommittee that waters surrounding Florida, including the south Atlantic and eastern Gulf of Mexico, in fact remain under consideration for offshore drilling and energy development. Secretary Zinke had announced on January 9th he was exempting Florida from the Interior’s proposed 2019-2024 National Outer Continental Shelf (OCS) Oil and Gas Leasing Program. However, testifying in mid-January before the House Subcommittee on Energy and Mineral Resources, BOEM’s Dr. Walter Cruickshank contradicted that position, telling lawmakers that Florida was still being considered under offshore drilling plans by the Interior. “It is not a formal action,” Dr. Cruickshank said of Zinke’s decision on Florida. “They are still part of the analysis until the secretary gives us an official decision otherwise.”

The Trump Administration has begun hosting public meetings across the country to solicit feedback on the government’s proposed National OCS program. The BOEM will be in Austin to hear from stakeholders on February 6th -- to learn more, visit <http://bit.ly/2DQQUiN>.
