Congressman seeks to undo Dunes Sagebrush Lizard ESA listing

U.S. Representative August Pfluger (TX-11) has introduced legislation in Congress that seeks to overturn the U.S. Fish and Wildlife Service's (USFWS) [recent listing](#) of the Dunes Sagebrush Lizard as endangered. Listing the Sagebrush Lizard under the Endangered Species Act (ESA) is an incredible threat to energy production developed in the Permian Basin, warned the West Texas congressman, and does not adequately account for voluntary conservation agreements already in place in Texas and New Mexico that are helping the lizard species. As such, Congressman Pfluger announced on May 31st he has filed a Congressional Review Act (CRA) resolution that would block the USFWS' final rule listing the Dunes Sagebrush Lizard as an endangered species.

"Listing the Dunes Sagebrush Lizard as an endangered species is another effort by the Biden Administration to shut down drilling in the Permian Basin," declared Congressman Pfluger. "My CRA nullifies President Biden's attempt to use a lizard as a weapon against the oil and gas industry. I will not allow the president to take control of private property and kill energy jobs in the Permian Basin."

As [TIPRO has reported to members](#), in May, the USFWS made a determination extending endangered species status for the Dunes Sagebrush Lizard, a lizard species found only in West Texas and southeastern New Mexico. The reptile's ESA listing will become effective on June 20, 2024.

Despite the endangered determination, as of December 31, 2022, through state and private conservation efforts in New Mexico alone, 1,905,120 acres have been enrolled in a Candidate Conservation Agreement (CCA) and Candidate Conservation Agreement with Assurances (CCAA) by the ranching community and over 2.2 million acres have been enrolled in the CCA and CCAA by the oil and gas industry to protect the Dunes Sagebrush Lizard. For more than a decade, the Texas oil and gas industry has also worked alongside regulators, landowners, and other stakeholders to voluntarily protect the dune sagebrush lizards and their habitats – read more about these efforts by [clicking here](#).

Chairman's message

TIPRO members,

We have made it through the first half of the year and it's been quite an active six months for TIPRO and our industry. While Texas producers have continued to work hard in 2024 to provide affordable, reliable and secure energy for our state, the country and our allies, we have had to continue to confront heightened regulatory activity and promulgation of impactful energy policies by the Biden Administration. This includes, for example, the U.S. Environmental Protection Agency's (EPA) recent rule expanding methane emissions reporting requirements for petroleum and natural gas systems under subpart W of the EPA's Greenhouse Gas Reporting Program (GHGRP), New Source Performance Standards OOOOb/c, EPA rules for fossil fuel-based power plants, new regulations by the Department of the Interior's Bureau of Land Management (BLM) regarding the fiscal terms of the onshore federal oil and gas leasing program, along with other comprehensive reforms to the National Environmental Policy Act (NEPA). The Biden Administration's "temporary" pause in permitting of liquified natural Gas (LNG) exports also still remains in place, though it was first announced in January, and there are many other concerning directives from the White House and federal government which will hamper America's energy advantage and leadership. On behalf of the association's membership, TIPRO continues to engage on these detrimental policies and is working in partnership with other industry groups to counter inapt rules and federal mandates that impact the oil and gas industry, jeopardize jobs, hurt the economy and threaten our energy independence.

At the state capitol in Austin, meanwhile, work for the legislature's interim session has been ramping up. Texas Lieutenant Governor Dan Patrick and House Speaker Dade Phelan this Spring released interim charges for lawmakers to study in the coming weeks and months, which will set the stage for the major issues and topics that will be addressed during the 89th Legislature coming up next year. This interim session, there are over 125 charges that have been issued between the two legislative chambers, including many intended to further examine issues related to property taxes, as well as Texas' water and energy supply needs. TIPRO is tracking charges across 15 legislative committees and specifically monitoring interim legislative work that involves state action on water reuse expansion, road traffic, port infrastructure and increased electric transmission to oil-producing areas. Our association also is watching how committees in the Texas House of Representatives and Texas Senate examine charges that weigh the implications of federal regulations and explore potential legislative measures that will ensure a balanced approach promoting regulatory compliance while preserving economic vitality. This week, TIPRO testified before the Senate Natural Resources & Economic Development at a public hearing entitled "Overcoming Federal Incompetence."

Additionally, over the interim, TIPRO is also keeping a close eye on charges directing committees to monitor the progress of bills that were passed in the last legislative cycle pertaining to workforce development, programs established and funded under the Texas Emissions Reduction Plan (TERP), the new Texas Water Supply Fund, the Texas Water Fund, the Texas Energy Fund and the Texas Jobs Energy Technology and Innovation Act.

With more than 78 years' experience advocating for producers and royalty owners in Texas, TIPRO has maintained our leading advocacy work on behalf of our members. The association provides an essential role in giving a unified voice on issues of greatest concern to the Texas oil and gas industry. I hope you will join us for [TIPRO's Summer Conference](#) on August 19-20, as we dive deeper into the issues and trends impacting the Texas oil and natural gas industry.

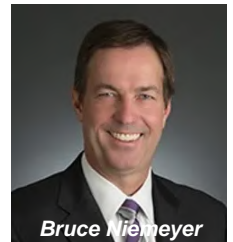

Nathan McDaniel joins Railroad Commission as agency's new government relations director

The Railroad Commission of Texas welcomed a new government relations director, Nathan McDaniel, in June. McDaniel, who started work at the regulatory agency last week, brings a strong record of legislative and private industry experience to his position, said the commission. He will take on a critical role overseeing the implementation of all state legislation and any relevant federal legislation at the agency, as well as preparing the Railroad Commission for the next legislative session that begins in January 2025.

"I'm thrilled for the opportunity to work with the commissioners and agency staff to ensure Texas continues to lead the way in energy production and environmental stewardship," said McDaniel. "As a lifelong Texan, I know how critical these resources are not only to our great state, but to the entire country. Working together with my colleagues at the Railroad Commission and other state and industry leaders, I am confident Texas will continue to lead the world in innovative and responsible ways to produce the energy resources we need."

Before joining the Railroad Commission, McDaniel served as communications director for a Texas state senator and was campaign manager and district director for a member of the United States House of Representatives. In these roles, McDaniel engaged community leaders and government officials on a variety of policy issues, including energy and environmental policies. In his most recent role, he consulted state and local public sector entities on strategic communications and marketing efforts. McDaniel holds a bachelor's degree from Texas State University and a Master's in Public Leadership from the LBJ School of Public Affairs at the University of Texas.

Registration now open for Railroad Commission's annual regulatory conference

Industry representatives and energy professionals can now sign up for the Railroad Commission of Texas' annual Regulatory Conference, taking place July 30-31, 2024, in Austin at the AT&T Hotel and Conference Center. The agency's conference will inform and train oil and gas and pipeline operators on the applicable laws, rules, and procedures for hydrocarbon production in Texas. This conference will feature over 60 sessions covering a variety of topics including: environmental permitting and compliance, inactive well compliance and inactive well test reporting; organization reports and financial assurance; oil and gas completions; production reporting; critical infrastructure inspections and audits and critical infrastructure forms online filing; and much more!

In addition to presentations from commission staff, the regulatory conference will feature presenters from Energy World, Industrial Training Services, Mears Group, Inc., National Transportation Safety Board, PHMSA, RCP Inc., RegSafe and Southern Methodist University (SMU). This year's conference also will again feature exhibitors.

The registration fee for the conference is \$450 per person if registered by June 30, 2024, and \$550 per person if registered on or after July 1, 2024.

Apache Corporation opens applications for tree donation program

Apache Corporation, a subsidiary of APA Corporation and member of the Texas Independent Producers and Royalty Owners Association (TIPRO), has opened applications for the company's annual Tree Grant Program. The charitable program, administered by Apache since 2005, focuses on large-scale conservation, protection of habitats for wildlife and native species, as well as the restoration and enhancement of public greenspaces. The environmental stewardship initiative in the past has been honored with conservation awards and allowed the oil and gas company to leave a lasting positive impact for current and future generations. More than 5 million trees have been donated over the years through the Apache Tree Grant Program to over 1,000 non-profit charitable partners and government agencies in the U.S.

"At Apache, we believe that energy production and environmental stewardship work hand-in-hand," said John J. Christmann IV, Apache's chief executive officer. "Responsible energy development and conservation are not mutually exclusive. The impressive growth of our program demonstrates how as an oil and gas company we can responsibly meet global energy needs while also supporting large-scale conservation projects and the enhancement of public greenspaces. The program helps ensure that future generations can benefit from the steps we take today to create a more sustainable world."

The program is open to U.S.-based nonprofit organizations and government agencies in states where Apache has oil and gas operations — currently Texas, New Mexico and Louisiana. The deadline to apply for this year's program is July 12, 2024. Grant awards will be announced October 1, 2024.

Congressional panel dives into significant need for more energy to support America's digital future

Members of the U.S. House Energy and Commerce Committee met in earlier this month to examine the explosive demand for energy increasingly needed to adequately support innovative technologies like Artificial Intelligence (AI) and cloud services, which are growing exponentially. With AI and other computer services, more energy, electricity and power are going to be required to maintain data centers around the country.

"The data centers used to store and process the information that many of these emerging technologies utilize, along with the advanced manufacturing necessary to build them here at home, will require significantly more energy resources. Energy is foundational to everything we do," stated Committee Chair Cathy McMorris Rodgers (R-WA) at the hearing. "The cornerstone of this foundation is affordable, reliable electricity... The more electricity we have, the more we can accomplish and innovate as a nation."

"By some estimates, demand will grow by 5 percent per year nationwide through the end of the decade. But in certain parts of the country, demand could grow by as much as 20 percent," advised Jeff Duncan (R-SC), member of the House Energy and Commerce Committee and chairman of the House Energy and Commerce Subcommittee on Energy, Climate, and Grid Security. "Regardless of the exact number, we know electricity demand is surging in many places because of data center growth, new manufacturing, and electrification. This electricity demand from data centers and manufacturing is not like residential demand that uses a little electricity here and there and can be asked to turn off through demand response and virtual power plants. Many of these enterprises run non-stop at 90 percent of their full potential. They can't afford disruptions, shortfalls, or blackouts; they require 24/7/365 electricity to power American innovation. If data centers, including those using AI, need constant power, they cannot rely upon intermittent resources for that firm, dispatchable power."

NOAA's hurricane season forecast shows heightened risk to the oil and gas industry

This year's hurricane season could be one of the worst ever recorded, meteorological scientists from the National Oceanic and Atmospheric Administration (NOAA) are warning. NOAA recently issued its highest on-record hurricane forecast, predicting greater hurricane and storm activity due to a confluence of factors, including near-record warm ocean temperatures in the Atlantic Ocean, development of La Niña conditions in the Pacific, reduced Atlantic trade winds and less wind shear, all of which tend to favor tropical storm formation.

NOAA's new weather outlook predicts between 17 and 25 named storms this year, compared to an average of 14; between eight and 13 hurricanes, compared to an average of seven; and between four and seven major hurricanes, compared to an average of three.

Weather threats from the tropics, including an increase in storm and hurricane activity, can present heightened risk for weather-related production outages in the U.S. oil and natural gas industry. As explained by the U.S. Energy Information Administration (EIA), hurricanes primarily affect petroleum markets by disrupting crude oil production and refinery operations. [Offshore](#) crude oil in the United States is concentrated in the [Federal Offshore](#) Gulf of Mexico (GOM) and could be significantly limited by inclement weather. Offshore oil and natural gas floating production units must contend with some of the most severe hazards associated with hurricanes and tropical storms; they must have emergency procedures to evacuate non-essential personnel and temporarily halt production. [In 2023](#), GOM crude oil production accounted for 14 percent of U.S. crude oil production. Refining of crude oil is also affected by hurricanes in certain parts of the Gulf Coast. Refineries along the Texas and Louisiana Gulf Coast account for almost half of U.S. refining capacity. These facilities risk flooding or power outages associated with major storms or hurricanes. Like offshore floating production facilities, many refinery operators will evacuate non-essential personnel and temporarily stop production if they believe severe weather might injure employees or damage their facilities.

A hurricane could also reduce natural gas production in the GOM, which is mostly [associated gas production](#); however, recent hurricanes have had a much smaller impact on total U.S. natural gas supply because natural gas production in the GOM has been declining for years. The GOM [provided](#) less than 2 percent of total U.S. marketed natural gas production in 2023, down from 17 percent in 2005 when Hurricanes Katrina and Rita interrupted significant volumes of natural gas production, noted the EIA.

Hurricanes also can affect U.S. natural gas demand by interrupting liquefied natural gas (LNG) export and trade operations. The United States has nearly 13 billion cubic feet per day of LNG export capacity located on the Gulf Coast, making it vulnerable to weather-related disruptions like hurricanes. Although LNG facilities generally have many layers of protection from direct impact, hurricanes can damage electrical and marine infrastructure and hamper ship movement, the EIA explained. For example, the effects of [Hurricane Laura](#), which made landfall in August 2020, temporarily halted LNG exports from Louisiana's Sabine Pass and Cameron LNG facilities.
